## Prevention of corruption - institutional framework in Croatia



- Horizontal coordination: Ministry of Justice and Public Administration
  - Independent authorities:
    - The Commission for the Resolution of Conflicts of Interest
    - Information Commissioner
    - The Ombudsperson
    - The State Commission for the Control of Public Procurement Procedures
    - The State Audit Office
    - The State Election Commission
  - Government's advisory body for monitoring the implementation: Council for the Prevention of Corruption
  - Parliamentarian working body: National Council for Monitoring Anti-Corruption Strategy Implementation

## Strategic framework


- National development Strategy 2030 as umbrella strategic document, one of the strategic areas is fight against corruption
- New Strategy for prevention of corruption 2021-2030, three triannual action plans foreseen – 2022-2024, 2025-2027, 2028-2030

Specific Strategic goals are:

1. Strengthening the institutional and normative framework for the fight against corruption
  2. Increasing the transparency and openness of the work of public authorities
  3. Improving the system of integrity and conflict of interest management
  4. Strengthening anti-corruption potentials in the public procurement system
  5. Raising public awareness about the harmfulness of corruption, the need to report irregularities and strengthening transparency

## **New Strategy 2021 – 2030 – sources**

- the internal analysis of the implementation of previous Strategy,
  - international assessment documents (GRECO, European Semester, Rule of Law, OECD IPR, World Bank Analysis)
  - the results of the research conducted on the website of the Ministry of Justice and Public Administration were taken into account in order to obtain an assessment of the current state of perception of corruption among citizens, together with existing Eurobarometer or Transparency International surveys

## **Legislative activities**

We have adopted 2 new very important anti-corruption laws:

- Law on prevention of conflict of interest, December 2021
- Law on protection of reporters of irregularities (whistleblowers), April 2022

Next step: Law on lobbying



## International Framework

- EU – Rule of law report, national RRP(Resilience and recovery plan) – activities on anti-corruption
- OECD – reaching OECD standards; participating in the work of ACN, goal: to accede to Anti-Bribery Convention and joining Anti-bribery WG - project: Fighting bribery in international business transactions
- GRECO – recommendations from 5th evaluation report
- UNCAC – second evaluation cycle of IRM
- RAI

### Reforme

C2.6. R1	Povećanje učinkovitosti, koherentnosti i otvorenosti nadležnih tijela u borbi protiv korupcije kroz digitalizaciju, jačanje transparentnosti i unaprjeđenje koordinacije
C2.6. R2	Unaprjeđenje provedbe Zakona o pravu na pristup informacijama
C2.6. R3	Unaprjeđenje korporativnog upravljanja u trgovačkim društvima u većinskom vlasništvu jedinica lokalne i područne (regionalne) samouprave
C2.6. R4	Jačanje kapaciteta sudske zaštite u postupcima javne nabave



### Investicije

C2.6. R1-I1	Uključivanje šire javnosti u borbu protiv korupcije podizanjem javne svijesti o štetnosti korupcije, nužnosti sprječavanja i pravnoj zaštiti prijavitelja
C2.6. R1-I2	Digitalizacija etičkog sustava državnih službenika
C2.6. R1-I3	Unaprjeđenje postojećeg sustava imovinskih kartica državnih dužnosnika
C2.6. R1-I4	Podrška učinkovitosti u suzbijanju korupcije i organiziranog kriminaliteta
